OVERVIEW

Denis F. Alia concentrates his practice in the defense of litigation matters, including products liability, toxic torts, automotive accidents, insurance claims, and premises litigation. Denis periodically speaks at national conferences, where in the past he has addressed issues involving the statute of repose and its application in various jurisdictions, the evolution of remote depositions as the new discovery frontier, and liability concerns related to remote technologies including self-driving vehicles. Denis is an active member of the Defense Research Institute ("DRI"), where he is currently serving as Chair of DRI's Products – Regulatory, Risk, and Safety Specialized Litigation Group. Denis previously served as Co-Chair of the Corporate Counsel Development committee with the Young Lawyers group, and Vice-Chair of the Manufacturer's Risk Specialized Litigation Group. Denis also periodically publishes articles with the Defense Research Institute and American Bar Association.

While in law school, Denis interned at the Queens, New York Supreme Court and at the Suffolk County Superior Courthouse in Boston. Denis was also involved with the New York City Unemployment Action Center, where he represented clients in front of administrative law judges during employment termination hearings. Prior to starting his legal career, Denis worked as a portfolio analyst for a Fortune 100 insurance company where he focused on complex data analysis.
